SIZE AND CONDUCT OF EXHIBITS

Exhibits can be tabletop-Displays or may occupy the same space of a 6 foot table. Any signage must sit on the table top or occupy no more floor space than 30 inches by 6 feet. Exhibits will not be behind locked doors unless you make arrangements with the hotel management to store materials overnight.

TERMS OF PAYMENT

The exhibitor agrees to accept the space assigned. The application along with full payment for space should be returned to CAPS by email at exhibits@caps.net CAPS reserves the right to modify the designated exhibit space in the event a change in the original assignment is necessary.

CONTRACT FOR FACILITIES

The acceptance of the application by CAPS and the full payment for rental charges constitute a contract. A completed application for space with full payment and all requested information must be submitted by email. Applications must include a credit card number. Expiration date, and signature.

CANCELLATIONS

Exhibitors are requested to notify CAPS by email at exhibits@caps.net with cancellations. Cancellations are not effective until they have been submitted in writing to CAPS.
